a) the right to erasure

In some circumstances you have the right to the erasure of your personal data with undue delay.

b) the right to restrict processing;

You have the right to object to our processing of your personal data.

c) the right to object to processing;

You have the right to object to our processing of your personal data on grounds relating to your personal situation.

d) the right to data portability

You have the right to obtain and reuse your personal data for your own purposes.

e) the right to complain to supervisory authority;

If you consider that our processing of your personal information infringes data protection laws, you have a legal right to lodge a complaint with a supervisory authority responsible for data protection.

f) the right to withdraw consent;

Under certain conditions you have the right to withdraw consent for us processing your data.

## **Sharing of Personal Data**

#### Marketing
